Notice to Applicant

1. You will be required to provide documentation (such as a driver’s licence, passport or proof of age card) to prove your identity and age, as part of this application.
2. Every Dog/Cat over 3 months of age (other than those exempt pursuant to section 33 of the Act) must be registered.
3. Payment of the relevant registration fee and any fee for late payment of the registration fee must accompany this application.
4. Registration remains in force until 30 June next and may be renewed for further periods of 12 months.
5. The Registrar may refuse to register a Dog/Cat if satisfied that the Dog/Cat is kept in a kennel or used for a purpose in connection with a business that should, in the opinion of the Registrar, be registered under section 35 of the Act.
6. The Council is required to maintain a public register containing information regarding Dog/Cats it registers. The information sought on this form which has been marked with a * will be included in the public register.
