DOG REGISTRATION

Please be advised that Council will be conducting a door knock of all properties to check on unregistered dogs. Any dogs found unregistered will incur an expiation fine of \$170.00. Council urges anyone who has a dog that is 3 months of age or older to register their dog before the door knock occurs. Also please be aware that Councils by-laws state that all cats must be desexed, microchipped and registered. This by-law will be enforced as of 1 July 2018.
